Masters Men overall will receive a WNBFF Masters Pro Card. Ms. Fit Body, Bikini, & Men's Physique are Pro Qualifier's.

TESTING: All athletes will be polygraph tested to verify their **7-year's natural status**.

POLYGRAPH FEE: \$40 payable on the day of the test in cash. Call (912) 695-0400 to schedule an appointment.

POLYGRAPH TEST DATES: July 13, 2019. These fill up quickly so call to reserve your time ASAP.

AWARDS: 1st-5th place in each weight class and Overall. Figure 1st-5th place in each class.

MUSIC: Athletes are required to bring their own music. Music must be on a CD and cued.

MAXIMUM TIME ALLOWANCE (60SECONDS STRICTLY ENFORCED): A professional -quality 60-second recording is recommended.
