Failure to sign any liability, drug testing or any other release form will result in the forfeiture of the right to participate or receive prize money and loss of WNBF eligibility.

**ENTRY FEE:** \$150 - Certified check or money order only. (NO ENTRIES ACCEPTED DAY OF CONTEST!)

**POLYGRAPH FEE:** \$40 payable on the day of the test in cash. Call (912) 695-0400 to schedule an appointment.

**POLYGRAPH TEST DATES:** March 20th, 21st, and 22nd. These fill up quickly so call to reserve your time ASAP

**URINE TESTING:** Prize money winners will be tested at night immediately after they come off stage.

**MUSIC:** Athletes are required to bring their own music. Music must be on a CD and cued.

**MAXIMUM TIME ALLOWANCE (60SECONDS STRICTLY ENFORCED):** A professional –quality 60-second recording is recommended.

I, \_\_\_\_\_, agree to compete in the “**2018 WNBFF Pro Iron Eagle Classic**. Which will be held on Saturday, **March 10, 2018** in Savannah, Georgia. I understand that I am responsible to attend the Prejudging and Night Show of the competition, and participate in all scheduled mandatory drug testing that is required for my participation in the WNBFF Pro International Ch. I am also responsible to attend any publicity functions (photo shoots, interviews, media meetings, seminars, etc.) deemed necessary by the WNBFF to promote the competition. If I fail to attend any mandated activities, I will forfeit my entry fees and will be suspended from membership and participation in WNBFF events for a period of two (2) years from the contest date, plus I will be forced to requalify for the WNBFF from the INBF amateur ranks after the suspension time is served, should I wish to rejoin the WNBFF. I agree not to do any promotions nor many any appearances for companies, organizations or media outlets (print, TV or radio) that are not associated with the WNBFF or WNBFF Tournament of Champions. Any unauthorized appearance will result in my removal from the competition and suspension for the WNBFF membership for two (2) years.
