A WNBF Pro card will be awarded to the overall winner of the Open Men's & Women's divisions. The Figure division overall winner will receive a WNBF Pro card. Masters Men overall will receive a WNBF Masters Pro Card. Ms. Fit Body, Bikini, & Men's Physique are Pro Qualifier's.

**TESTING:** All athletes will be polygraph tested to verify their **10-year's natural status**.

**POLYGRAPH FEE:** \$40 payable on the day of the test in cash. Call (912) 695-0400 to schedule an appointment.

**POLYGRAPH TEST DATES:** March 17<sup>th</sup>, and 18<sup>th</sup>. These fill up quickly so call to reserve your time ASAP.

**AWARDS:** 1st-5\* place in each weight class and Overall. Figure 1st-5\* place in each class.

**MUSIC:** Athletes are required to bring their own music. Music must be on a CD and cued.

**MAXIMUM TIME ALLOWANCE (60SECONDS STRICTLY ENFORCED):** A professional -quality 60-second recording is recommended.
